Environmental Health Science Concentration Competencies

6. Demonstrate basic data management and analysis skills using statistical software such as SAS by translating raw epidemiologic data into actionable public health information.
7. Identify the principles and limitations of public health screening programs
8. Explain the importance of epidemiology for informing scientific, ethical, economic, and political discussion of health issues
9. Evaluate the strengths and limitations of epidemiological research and reports.

Health Policy & Management Concentration Competencies

1. Effectively use data to identify potential policy solutions, implementations, and strategies for monitoring health policy outcomes.
2. Identify the health equity and ethical issues impacting policy development and policy options to resolve public health problems.
3. Demonstrate effective communication skills such as writing to securing grant funding, or developing educational materials, or writing policy brief or publishing evaluation reports. (3)
